Solar Landfill Project Advances

The NJMC took a major step forward last month in its plan to transform a closed landfill into the state's largest solar power generator. The Commission invited companies to submit proposals to develop a solar power facility on 35 acres of a former landfill in Kearny, a site estimated to be large enough to hold enough solar panels to generate 5 megawatts of power, which would make it the largest solar operation in New Jersey. The Commission is seeking a company that would design, finance, own and operate the solar facility. The company would generate revenue by selling electricity to the power grid, and through financial incentives offered to solar energy producers by the state and federal governments. The Commission plans to review completed proposals later

this summer. The solar landfill project supports objectives of the NJMC Energy Master Plan and Governor Corzine's Energy Master Plan for New Jersey, both of which call for increasing the amount of power generated from renewable energy sources, like sun and wind. The NJMC's renewable energy efforts date back to 1987, when the Commission started selling methane collected from its landfills for electric conversion. Last year the NJMC opened an award-winning sustainable design classroom building whose solar panels provide nearly 40 percent of the building's electricity needs, and the Commission is currently working with local communities to help them outfit public buildings with solar panels.



NJMC to Strengthen Redevelopment Regulations

The NJMC is drafting regulations that will strengthen the Commission's oversight of area redevelopment projects. The new rules, which stem from past experiences including the EnCap project, will enable the NJMC to more closely evaluate a potential redeveloper's financial status and better protect the region - and any public tax dollars involved in these projects. The changes will require potential redevelopers to undergo an independent financial review before they could be selected as a redeveloper and before any redevelopment contract could be signed. Redevelopers would also

be required to inform the NJMC if they are seeking loans, bonds, or other financial assistance from any state agency, department, commission or authority, and if they discuss PILOT bonds with municipalities. In addition, the strengthened regulations will require developers to submit to the Commission copies of any permit applications made to federal, state or regional agencies, and they will include new provisions on testing soils slated for fill at a project site. The public will have a chance to comment on these new rules during hearings that will be held in the next few months.

Business Accelerator Client Awarded Grant

Solaris Cybernetics, a client of the NJMC Business Accelerator, has received a new grant aimed at helping start-up businesses grow and prosper. The \$55,000, state-funded New Jersey Business Incubation Network Pre-Seed Grant is awarded to companies that show strong potential to create high tech jobs in the next three years. Solaris Cybernetics is a renewable energy company developing robotic technology to produce fuel from algae, a project the grant will help fund. In addition to the money, the award allows Solaris Cybernetics to also receive mentoring from a member of the technology business community. Thanks to a \$1.5 million grant from the NJMC, the Business Accelerator opened last year with a mission to help early-stage companies focused on green technology grow and succeed.
