#### **NEW JERSEY MEADOWLANDS COMMISSION SECURITY CONTRACT BG 10-003**

The New Jersey Meadowlands Commission (hereinafter, "NJMC") is accepting Proposals from security firms (hereinafter, "Bidder," "Contractor," or "Firm") seeking to provide unarmed security guard services for the NJMC at One, Two and Three DeKorte Park Plaza, Lyndhurst, NJ. All Proposals (hereafter "Proposal", "Bid" or "Submission") received must conform to the terms and requirements of this Request for Proposal (hereinafter, "RFP"). The NJMC reserves the right to waive minor irregularities and discrepancies in any Proposal, request supplemental information from any Bidder, abandon all or part of this project prior to award of the contract, and reject any and all Proposals if it is deemed to be in the best interest of the NJMC to do so.

Contract Documents will be available at the NJMC offices located at One DeKorte Park Plaza, Lyndhurst, N.J. 07071, on Monday, November 29, 2010, after 10:00 AM, and may be examined at that time. Copies of the Contract Documents may be obtained upon payment of a non-refundable fee of \$40.00 for each set. The Contract Documents do not have to be returned. All costs for mailing the Contract Documents will be charged to each firm requesting such service. The mailing costs and the fee must be received before the Contract Documents will be mailed.

On Monday, December 6, 2010 there will be a Mandatory Pre-Bid Meeting held at One DeKorte Park Plaza at 10:00 a.m. prevailing time. All bidders who are purchasing plans and specifications must furnish the New Jersey Meadowlands Commission with a fax number at the time of purchase, as any Addendum will be issued and forwarded via fax transmission.

Your attention is particularly called to the New Jersey State requirements regarding conditions of employment and affirmative action. Bidders are required to comply with the requirements of N.J.S.A. 10:5-31 et seq. and N.J.A.C. 17:27.
